# THE TRUNK ROAD (WIND STREET AND COLLEGE STREET, AMANFORD) (RESTRICTION OF WAITING) ORDER 1966

Notice is hereby given that the Secretary of State proposes to make an Order under sections 26 and 28 of the Road Traffic Act 1960, the effect of which

1. to revoke the Trunk Road (Wind Street and College Street, Amanford) (Restriction of Waiting) Order 1959 and the Trunk Road (Wind Street and College Street, Amanford) (Restriction of Waiting) (Amendment) Order 1964.

2. to prohibit waiting between 9 a.m. and 6 p.m. on any day other than a Sunday.

on any day other than a Sunday:

(a) on any of the sides of road or in the length of road specified in Schedule 1 to this Notice; or

(b) on either of those sides of road specified in Schedule 2 to this Notice, for a longer period than 40 minutes in any hour.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services

#### SCHEDULE 1

Sides and a length of the Swansea-Manchester Trunk Road (A.483) (hereinafter referred to as "the trunk road")

1. The south-east side of that length of the trunk road, known as Wind Street in the Urban District of Amanford, which extends from its junction with College Street in the said Urban District, to a point 35 yards south-west of its junction with Tirydail Lane in the said Urban District.

4. That length of the trunk road, known as College Street in the Urban District of Amanford, which extends from its junction with Wind Street aforesaid to a point 15 yards north-west of its junction with Iscennen Road in the said Urban District.

## THE TRUNK ROAD (COLWYN BAY) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT) ORDER 1966

Notice is hereby given that the Secretary of State proposes to make an Order under section 28 of the Road Traffic Act 1960, the effect of which will be to amend the Trunk Road (Colwyn Bay) (Prohibition and Restriction of Waiting) Order 1961 so that waiting will be prohibited between 8 a.m. and 7 p.m.

1. in those lengths of the Chester—Bangor Trunk Road (A.55) in the Borough of Colwyn Bay,

specified in the Schedule hereto; and

in the length of said Trunk Road which lies between its junction with Rhiw Road and its junction with Nant-y-Clyn Road:—

(i) on the north-east side on the days of the month which bear even numbers;

(ii) on the south-west side on the days of the

month which bear odd numbers;

(iii) on the side of road on which vehicles will not for the time being be prohibited from waiting by (i) or (ii) above, for a longer period than 45 minutes in any 2 hours.

#### The Newtown-Aberystwyth Trunk Road (Penstrowed Bridge) Order, 1966
