On the 20th January 1966, at Darwin River Quarry, Northern Territory, a helicopter appeared to fly into a power line and then crash to the ground, bursting into flames. The only occupant, the pilot, sustained burns, lacerations and abrasions.

Mr. Mathews and Mr. Brown, in spite of the danger of the machine exploding, rushed to the wreckage to extricate the pilot, who was then unconscious. It was impossible to undo the safety belt at first because of the slumped position of the pilot. When the pilot was released he was found to be further restrained with part of the aerial cable, which was very hot, around his chest.

After the pilot had been lifted clear of the aircraft, it exploded. Had it not been for the courageous

to death.
