TOWN AND COUNTRY PLANNING ACT 1962

Heath and Reach, Beds

The Minister of Transport hereby gives notice that she proposes to make an Order under sections 153 and 217 (3) of the above Act (i) revoking The Stopping up of Highways (County of Bedford) (No. 5) Order 1959 and (ii) authorising the diversion of a length of footpath at Heath and Reach, Beds, in order to enable development, consisting of the extraction of minerals to be carried out in accordance with planning permission granted to P. G. Boyce (for Bedford Silica and Sand Mines, Ltd.) by Luton R.D.C.

The diversion to be authorised will involve the provision of a new footpath maintainable at the public expense, for which the highway authority is to be the Bedford C.C.

During three months from the 25th October 1966, copies of the draft Order and relevant plan may be inspected free of charge at all reasonable hours at the Luton R.D.C. Heath and Reach, Beds
