THE TRUNK ROAD (JUNCTION OF WARRAGE LANE, RAGLAN) (PROHIBITION OF ENTRY) ORDER 1966.

Notice is hereby given that the Secretary of State has made an Order under section 26 of the Road Traffic Act 1960, the effect of which is that no person shall cause any vehicle to enter Warrage Lane, Raglan, in the county of Monmouth, from the Newport — Monmouth — Ross-on-Wye — Worcester Trunk Road (A.40) in that county.
