# ROAD TRAFFIC ACTS

### FOLKESTONE BOROUGH COUNCIL

The Borough of Folkestone (Traffic Regulation) (Various Roads) (No. 3) Order 1966

Bouverie Place—The order on the western side of Bouverie Place be extended for a distance of 18 feet northwards.
