TOWN AND COUNTRY PLANNING ACT 1962

Bath

The Minister of Transport hereby gives notice that she has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (City and County Borough of Bath) (No. 3) Order 1966" authorising the stopping up of Midsummer Road, and a length of adjacent footpath, Bath and requiring the provision of a new highway and of a new footpath.
