### REPORT OF THE NATIONAL BOARD FOR PRICES AND INCOMES

#### *Rate of Interest on Building Society Mortgages*

On 24th May 1966 the Government referred the question of the rate of interest on building society mortgages to the National Board for Prices and Incomes for examination under the terms of the Royal Warrant constituting the Board as a Royal Commission.

Since that date the Board has been reconstituted under section 1 of the Prices and Incomes Act 1966 and to enable the Board to make its report on this reference in accordance with the Act the First Secretary of State, the Chancellor of the Exchequer and the Minister of Housing and Local Government formally referred the question to the Board under section 2 of the Act on 2nd November 1966.

The Board has now made its report and in accordance with section 5 (1) of the Prices and Incomes Act 1966 the First Secretary of State, the Chancellor of the Exchequer and the Minister of Housing and Local Government hereby give notice that the report was first published as Command Paper Number 3136 on 14th November 1966.
