Notice is hereby given that the Northamptonshire County Council have made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit the driving of vehicles on the length of road specified in the first column of the Schedule to this notice otherwise than in the direction specified opposite to that length in the second column of the said Schedule.

The Order came into operation on 21st November 1966.

POOLE BOROUGH COUNCIL

Poole (Various Roads, Pottery Junction Area) (Prohibition of waiting, loading and unloading and right-turn) Order, 1966.

Notice is hereby given that the Poole Borough Council propose to make an Order under the Road Traffic Act, 1960, the effect of which will be as follows:

- (i) To prohibit waiting by vehicles at all times in the lengths of road specified in Part I of the Schedule attached hereto.
- (ii) To prohibit waiting by vehicles between the hours of 8 a.m. and 7 p.m. on all days other than on Sundays in any of the lengths of road specified in Part II of the Schedule attached hereto.
- (iii) To prohibit the loading or unloading of goods (other than by Post Office vehicles) between the hours of 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. in any of the lengths of road specified in Part III of the attached Schedule.
- (iv) To prohibit any vehicle proceeding in Ashley Road from making a right-hand turn into Becher Lane.
- (v) That every vehicle proceeding in a southerly direction in Alder Road shall, on reaching the junction of Alder Road and Ashley Road, turn left.
- (vi) To amend the Borough of Poole (Traffic Regulation) (No. 1) Order, 1952, by the substitution of the length of road described in Part IV of the Schedule attached hereto for the length of road described in Article 1 of the said 1952 Order.
- (vii) To amend the Borough of Poole (Traffic Regulation) (No. 1) Order, 1954, by the deletion therefrom of the length of road described in paragraph 2 of the Schedule to that Order.
- (viii) To revoke the Council of the Borough of Poole (Traffic Regulation) (No. 2) Order, 1957.
- (ix) To revoke the Borough of Poole (Pottery Junction Area) (Prohibition of Waiting) Order, 1959.

Exceptions will be provided in the proposed Order as to the prohibition of waiting to permit loading or alighting from vehicles; loading or unloading of goods (except as aforementioned); building operations, road maintenance or other similar works; and to enable a vehicle to be used in connection with a funeral.

Objections to the proposals must be sent in writing to the undersigned by 10th December 1966.

THE SCHEDULE

PART I

Lengths of Road in the Borough of Poole

(a) *Poole Road and Ashley Road (northern side)* from a point opposite the boundary between numbers 459 and 457 Poole Road to the east side of the public conveniences in Ashley Road.

(b) *Poole Road (southern side) and Bournemouth Road (south-eastern side)* from the boundary between

numbers 459 and 457 Poole Road to the north-eastern boundary of St. Aldhelms School, Bournemouth Road.

(c) *Ashley Road (southern side)* from the western boundary of Number 7 Ashley Road to its junction with Bournemouth Road.

(d) *Bournemouth Road (north-west side)* from its junction with Ashley Road for a distance of 40 yards in a south-westerly direction.

PART II

Lengths of Road in the Borough of Poole

(a) *Ashley Road (north side)* from the eastern boundary of the public conveniences to the western boundary of number 42 Ashley Road.

(b) *Ashley Road (south side)* from the western boundary of number 7 Ashley Road to a point opposite the western boundary of 64 Ashley Road.

(c) *Bournemouth Road (north-western side)* from a point 40 yards from its junction with Ashley Road to its junction with Becher Road.

(d) *Bournemouth Road (south-eastern side)* from the north-eastern boundary of St. Aldhelms School to its junction with Langley Road.

PART III

Lengths of Road in the Borough of Poole

(a) *Ashley Road (both sides)* from its junction with Bournemouth Road to the western boundary of 33 Ashley Road.

(b) *Bournemouth Road (both sides)* from its junction with Ashley Road to the south-western boundary of number 341 Bournemouth Road.

PART IV

Length of Road in the Borough of Poole

Poole Road from the boundary between numbers 459 and 457 Poole Road to the junction of Poole Road and St. Aldhelms Road.

SHEFFIELD CITY COUNCIL

The City of Sheffield (Snow Hill and Kirkby View) (Restrictions on Driving) Order, 1966

Notice is hereby given that the City and County Borough Council of Sheffield have applied to the Minister of Transport for confirmation of an Order made by them under section 26 of the Road Traffic Act, 1960, the effect of which will be:

- (a) To prohibit any person from causing any motor vehicle to proceed on any of the lengths of road specified in the Schedule hereto.
- (b) To prohibit any person from riding or causing to be ridden any pedal bicycle or tricycle on any of the said lengths of road.
- (c) To provide that, it being requisite for avoiding danger to persons or other traffic using the said lengths of road, subsection (4) of section 26 of the Road Traffic Act, 1960, as amended by section 12 of the Road Traffic and Roads Improvement Act, 1960, should not apply in relation to the Order.

A copy of the proposed Order and maps showing the lengths of road affected and the alternative routes available for vehicular traffic may be inspected at my office during normal office hours.

Objections to the Order must be sent in writing to the Secretary, Ministry of Transport (R.T.C.) at St. Christopher House, Southwark Street, London S.E.1, by the 17th December 1966, and a copy sent to the undersigned.
