The County of East Sussex (Various Laybys, Burgess Hill) (Limited Waiting) Order, 1966

Notice is hereby given that on the 3rd November 1966, the East Sussex County Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit vehicles waiting (with certain exceptions including that to enable goods to be loaded on to or unloaded from a vehicle) between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive:

(a) in any of the laybys referred to in the First Schedule hereto for a longer period than 30 minutes in any hour; and

(b) in any of the laybys referred to in the Second Schedule hereto for a longer period than one hour in any two hours.

EAST SUSSEX COUNTY COUNCIL

The County of East Sussex (Various Roads, Crowborough) (Prohibition of Waiting and Loading and Unloading) Order.

Notice is hereby given that the East Sussex County Council propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be:

1. To revoke:

(i) The County of East Sussex (Traffic Regulation) (Crowborough) Order (No. 1), 1957;

(ii) The County of East Sussex (Croft Road, Crowborough) (Prohibition of Waiting) Order, 1962;

(iii) The County of East Sussex (Traffic Regulation) (Crowborough Cross) Order (No. 5), 1954;

(iv) Articles 1 and 3 of the County Council of East Sussex (Traffic Regulation) (Crowborough) Order (No. 1), 1950.

2. To prohibit vehicles waiting:

(i) at any time in the lengths of road specified in the First Schedule hereto;

(ii) between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive in the lengths of road specified in the Second Schedule hereto;

(iii) between the hours of 8 a.m. and 6 p.m. (hereinafter referred to as "the said hours") on Mondays to Saturdays inclusive in the lengths of road specified in the Third Schedule hereto:

(a) for a longer period than 30 minutes, or

(b) if a period of less than 30 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in those lengths of road.

3. To prohibit goods being loaded on to or unloaded from vehicles except between the hours of 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. in the lengths
