REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Pay of Chief and Senior Officers in the Local Government Service

Before the Prime Minister's request for a standstill on prices and incomes on 20th July, pay increases had been proposed for certain staff covered by the Joint Negotiating Committees for Town Clerks and District Council Clerks and for Chief Officers of local authorities in England and Wales and subsequently a claim has been made for Chief Officials of local authorities in Scotland.

Clerks of County Councils in England and Wales, unlike their counterparts in Scotland and Northern Ireland, have their pay determined separately from that of the Clerks and Chief Officers of other Councils in England and Wales.

In pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966 the First Secretary of State, the Secretaries of State for Scotland and Wales and the Minister of Housing and Local Government hereby refer to the National Board for Prices and Incomes for examination, concurrently with their examination of Chief and Senior Officers of the Greater London Council;

- (a) the salaries of staff subject to—
- (i) the Joint Negotiating Committee for Clerks of County Councils in England and Wales;
 - (ii) the Joint Negotiating Committee for Town Clerks and District Council Clerks (England and Wales);
 - (iii) the Joint Negotiating Committee for Chief Officers of local authorities (England and Wales); and
 - (iv) the Joint Negotiating Committee for Chief Officials of local authorities (Scotland);
- (b) the salaries of the Secretaries of County Councils, Town Clerks, Clerks to District Councils and Chief Officers of local authorities in Northern Ireland and their respective deputies;
- (c) the system for determining these salaries.

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Pay of Chief and Senior Officers of the Greater London Council

The Greater London Council was established by the London Government Act 1963 and came into full operation on 1st April 1965. The salaries of its heads of departments and other senior officers were temporarily based on those formerly payable by the London and Middlesex County Councils, though with certain interim adjustments.

The Council now desire to lay down definitive salary scales based on a review by an independent two-man committee, which would involve substantial increases in individual cases, with effect from a date yet to be determined between 1st April 1965 and 1st January 1966.

In pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966 the First Secretary of State and the Minister of Housing and Local Government hereby refer to the National Board for Prices and Incomes for examination, concurrently with their examination of the salaries of other Chief and Senior Officers in local government service and the system for determining these, the salaries proposed for Chief and Senior Officers of the Greater London Council.
