The QUEEN has been graciously pleased to approve the undermentioned awards in recognition of gallant conduct in Aden:

Military Cross

Lieutenant Peter David ORWIN (477808) The Prince of Wales's Own Regiment of Yorkshire.

Lieutenant Peter Orwin, in command of 7 Platoon, "B" Company, 1st Battalion The Prince of Wales's Own Regiment of Yorkshire, was based at Habilayn Camp in the Radfan during July 1966.

On 27th July, Lieutenant Orwin was ordered to lay an ambush at a point a mile East of the Camp and to destroy the enemy moving on Habilayn during the night. (It was the fifth successive night that Lieutenant Orwin had ambushed routes leading to Habilayn.) The total strength of his patrol was fourteen.

A few minutes after 11 p.m. some fifteen to twenty dissident tribesmen moved into a sunken track to the rear of the ambush position. The section covering this approach waited until the enemy were within their position and then sprung the ambush. When fire was opened Lieutenant Orwin went to the rear section with a Non-Commissioned Officer and they together engaged the enemy at point blank range.

Enemy reaction was swift; two Blindicide rockets were fired at a range of twenty yards at the right hand fire group, killing a junior Non-Commissioned Officer and stunning the Platoon Sergeant. This left the Platoon's right flank unprotected. Two further rockets were fired injuring two more soldiers. In spite of the heavy enemy fire, and with complete disregard for his own safety, Lieutenant Orwin moved about his position to direct the fire of his machine guns and to adjust the position of other weapons in engaging the dissidents making their way round the flank. Then having moved two injured men to cover and learning that the right flank was silent, he took up a position alone and engaged the enemy rocket launcher team with grenades. Having thrown all his grenades, he called for mortar fire to be brought down on the enemy positions, directing and controlling the fire himself. The effect was such that the enemy then disengaged and withdrew having sustained casualties, which were subsequently confirmed, of one killed, one fatally wounded, six other wounded and a rocket launcher destroyed.

Lieutenant Orwin, in fighting this spirited action, pinned down and defeated an enemy stronger in number and armed with heavier weapons. In spite of the casualties sustained by his patrol, he displayed throughout this time high qualities of courage, tenacity and determination. By his personal example and leadership he was undoubtedly responsible for the successful outcome of the engagement.

Military Medal

23855438 Lance Corporal (acting Corporal) Alwyn Geoffrey AUKER The Prince of Wales's Own Regiment of Yorkshire.

On 29th June Corporal Auker was commanding a small observation post of three men on the roof of the old Political Officers house, 600 yards south of the main British Camp at Habilayn. He had been up country for only 24 hours. That night an attack by dissident tribesmen was mounted from the south with the British observation post as the main target. When the attack started, Corporal Auker moved his men under cover and contacted his company command post by radio.

Despite rocket launcher explosions on and below the roof parapet Corporal Auker tried to obtain a bearing and estimate the range to the enemy position, intense small arms fire was added to the rocket launcher fire and made this impossible. He therefore ran from the house across open ground to a sangar occupied by a Federal Guard section. Still under fire, though not so intense, he obtained an accurate fix on the enemy thus enabling supporting weapons to be brought to bear from the main British camp, and machine gun fire from one of the main piquets.

He then returned to his post and engaged the enemy with machine gun fire until they broke away and withdrew. Throughout the action he relayed accurate information back to his company commander.

His leadership, calmness and courage contributed largely to the haste with which the enemy broke off the engagement and were particularly commendable

because, despite his lack of experience, he displayed the best qualities of the British soldier to the Arab soldiers of the Federal Guard.

The QUEEN has been graciously pleased to give orders for the publication of the name shown below as having received an expression of Commendation for Brave Conduct:

22839202 Sergeant (acting Staff Sergeant) Thomas Alfred BARKER The Royal Anglian Regiment (now Parachute Regiment).

On 10th July 1966, whilst returning in a vehicle with his Check Point Party to his Unit lines in Aden, Sergeant (acting Colour Sergeant) Barker, observed a terrorist whom he had noted acting suspiciously, throw a grenade. Firing three quick shots from his vehicle, he immediately ordered his party into action, and without due regard to his own personal safety, gave chase through unsavoury Arab quarters. His cut off party, now in position ordered the terrorist to halt, and failing to do so, he was shot.

Colour Sergeant Barker's clear judgement, cool and courageous action undoubtedly saved casualties amongst his own men and was in the best tradition of his Regiment.

The QUEEN has been graciously pleased to give orders for the publication of the name shown below as having received an expression of Commendation for Brave Conduct (Posthumous).

23923390 Trooper (acting Lance Corporal) Roy Francis WILKINSON 4th/7th Royal Dragoon Guards, Royal Armoured Corps.

On 3rd August 1966, Lance Corporal Wilkinson was the Commander of a Saladin armoured car which was returning to its base camp in Southern Arabia to effect repairs. A section of infantry from the Federal Regular Army was travelling on the outside of the armoured car, as escort.

On descending a very steep and stoney track the brakes failed and the vehicle went out of control. Lance Corporal Wilkinson shouted to the Arab soldiers to jump clear, but this they were reluctant to do. Realising they would be killed or severely injured if they continued to cling on, and despite standing orders to the contrary, he climbed further out of his turret in an effort to push the soldiers off. He did this knowing that almost certainly he was sacrificing his own life.

The armoured car eventually overturned killing Lance Corporal Wilkinson and seriously wounding all but two Arab soldiers, who jumped clear.

Lance Corporal Wilkinson's actions, made with utter disregard for his own personal safety, showed outstanding heroism and was in the highest tradition of the Service.
