The QUEEN'S Most Excellent Majesty in Council Her Majesty, in exercise of the powers conferred upon Her by sections 659 and 738 of the Merchant Shipping Act 1894, c. 60, and section 1 of the Mer-chant Shipping (Amendment) Act 1920, c. 2, and of all the powers enabling Her in that behalf and by and with the advice of Her Privy Council, doth order, and it is hereby ordered, as follows: 1.-(1) This Order may be cited as the Trinity House (Remuneration of Members) Order 1966, and shall come into operation on the date of publication in the London Gazette. (2) The Trinity House (Remuneration of Members) Order 1964, printed in the London Gazette, 15th May

Order 1964, printed in the London Gazette, 15th May 1964, is hereby revoked. (3) The Interpretation Act 1889, c. 63, shall apply

(3) The Interpretation Act 1889, c. 63, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. 2. The sum to be paid to the active members of the Corporation of the Trinity House of Deptford Strond, being the General Lighthouse Authority for England and Wales, shall be £40,650 per annum in respect of the period from the 1st July 1965 to 31st August 1965; £42,450 per annum in respect of the period from 1st September 1965 to 28th February 1966; and £43,000 per annum in respect of any period after 28th February 1966. Provided that, in respect of any period during which there is a vacancy among the active members

the said sums shall be reduced by an amount equal to the sum which, but for the vacancy, would have been payable during that period to the active member concerned.

3. The sums payable under the provisions of this Order shall be paid out of the General Lighthouse Fund.

TREASURY

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 6th January 1967, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £150,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 9th January to Saturday the 14th January 1967, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than $\pounds 50,000$ and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

Banker, Discount House or Broker. 6. Notifications will be sent by post on the same day as. Tenders are received, to the persons whose Tenders are accepted in whole or in part and pay-ment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated. relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills. 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
