<i>Cross Street.</i>		
<i>George Street</i>	North side (except westernmost 60 yards).	
<i>Kings Road.</i>		
<i>Queens Road</i>	East side.	
<i>Waldegrave Street</i>	South side between its junctions with Queens Road and South Terrace.	
<i>East Street</i>	North side.	
<i>Swan Terrace.</i>		
<i>Pelham Place</i>	North side.	
<i>Sturdee Place</i>	North side between Pelham Place and 25 yards west of the eastern boundary of No. 11 Sturdee Place.	
<i>Grosvenor Gardens</i>	Between its junctions with Bexhill Road and Seaside Road.	
<i>Seaside Way</i>	The west side.	
<i>White Rock</i>	The north side from a point 95 yards west of its junction with Robertson Street to a point 62 yards west of that point.	
<i>Seaside Road</i>	The north side between its junction with Seaside Passage and a point 30 yards east of that junction.	
	The south side between its western end and a point opposite the eastern side of its junction with Seaside Way.	

The un-named road opposite the lower entrance to the West Hill lift linking George Street and Marine Parade.

North Street for a distance of 25 yards from its junction with London Road.

<i>Castle Street</i>	The north side from a point 10 yards east of the east side of its junction with Wellington Square to a point 64 yards east of that point.
<i>Hughenden Road</i>	The north side between its junction with Elphinstone Road and a point opposite the eastern side of its junction with Hughenden Place.
<i>Claremont</i>	The west side northwards from a point 49 yards south of a point opposite the north-west corner of Holy Trinity Church.
<i>Sedlescombe Road North</i>	The east side between a point 23 yards south of the south side of its junction with Alma Terrace and its junction with Chatham Road.
<i>Norman Road</i>	Both sides between a point 27 yards west of its junction with London Road and a point 5 yards east of its junction with Gensing Road.

HASTINGS COUNTY BOROUGH COUNCIL

The Hastings County Borough (Bohemia) (Waiting Restriction) Order 1967

Notice is hereby given that the Hastings County Borough Council on the 6th January 1967 made an Order under section 26 of the Road Traffic Act 1960 the effect of which is:

1. To prohibit save upon the direction or with the consent of a Police Constable the waiting of vehicles in the lengths of road set out in the First Schedule hereto.
2. To prohibit between the hours of 8 a.m. and 7 p.m. save as aforesaid the waiting of vehicles in the lengths of road specified in the Second Schedule hereto for longer than one hour in any three hours.
3. To provide in each case for exceptions to permit vehicles to wait for so long as may be necessary:

- (a) for passengers to board or alight,
- (b) for goods to be loaded or unloaded,
- (c) in connection with any funeral, building operation or demolition, the removal of obstructions to traffic or the maintenance of the roads and public utility services.

THE FIRST SCHEDULE

London Road. The west side between the southern side of its junction with Springfield Road and the north side of its junction with Tower Road West.

Lower South Road.

The south-east side between its junction with London Road and a point 10 yards east of that

junction and between its junction with Bohemia Road and a point 10 yards west of that junction.

The north-west side between its junction with London Road and a point 10 yards east of that junction and between its junction with Bohemia Road and a point 10 yards west of that junction.

North Road.

The south-east side between its junction with London Road and a point 10 yards east of that junction and between its junction with Bohemia Road and a point 10 yards west of that junction.

The north-west side between its junction with London Road and a point 10 yards east of that junction and between its junction with Bohemia Road and a point 10 yards west of that junction.

Tower Road.

The south-east side from London Road to the western side of its junction with Spring Street.

The north-west side between its junction with London Road and a point 10 yards east of that junction.

THE SECOND SCHEDULE

London Road. The east side between the south side of its junction with Woodland Vale Road and the southern boundary of No. 231 London Road.

Tower Road. The north-west side between a point 10 yards east of its junction with London Road and a point opposite the western side of its junction with Spring Street.
