Control Area, and (2) 'The City of Exeter (Stoke Hill No. 2) Smoke Control Order 1967' declaring the area described in the second Schedule hereto to be a Smoke Control Area

which said Orders have been submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Orders and by virtue of section 11 (4) of the Act, if, on any day after the Orders have some into operation, smoke is emitted from a chimney of any building within the Smoke Control Areas the occupier of that building shall be writer of an offense and linkle within the Smoke Control Areas the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity. If confirmed, the Orders will not come into opera-tion before the 1st day of May 1969 or before a later date determined by the Minister of Housing and Local Government.
