## FACTORIES ACT, 1961

On 31st January 1967 the Minister of Labour made the Work in Compressed Air (Prescribed Leaflet) Order, 1967. The Order which comes into operation on 10th February 1967 prescribes the leaflet containing advice on precautions to be taken in connection with work in compressed air. In accordance with Regulation 16 of the Work in Compressed Air Special Regulations, 1958, the leaflet is to be supplied by an employer to any person in his employment when
