#### TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the above Act to authorise the stopping up of a length of footpath at The Verlands, Cowbridge in the county of Glamorgan in order to enable residential development to be carried out in accordance with planning permission granted to Louis C. Fisher (Estate Management) Limited by Glamorgan County Council.

The proposed Order will also require the provision of two new footpaths maintainable at the public expense, for which the highway authority is to be the Glamorgan County Council, and another new highway.

#### HIGHWAYS ACT 1959

##### *The Newtown—Aberystwyth Trunk Road (Llanbadarn By-Pass) Order 1966*

The Secretary of State hereby gives notice that he proposes to make an Order under sections 7 and 44 of the above Act providing—

- (a) that a road which he proposes to construct at Llanbadarn in the County of Cardigan shall become a trunk road as from the date when the Order comes into operation, and
- (b) that the length of the Newtown—Aberystwyth Trunk Road to be superseded shall cease to be a trunk road as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Cardigan (who will become the highway authority responsible for that length) that the new trunk road is opened for through traffic.
