At the Court at Windsor Castle, the 12th day of April 1967.

Present,

The QUBEN'S Most Excellent Majesty in Council Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act, 1865, and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1. The Naval Re-engagement Grants Orders, 1965 and 1966 (which deal with the payment of re-engagement grants to certain categories of Naval engagement grants to certain categories of Navai ratings who re-engage to complete time for pension), shall continue to have effect for twelve months from the 31st March 1967, and accordingly in the first line of paragraph 6 of the Schedule to the Order in Council dated the 24th day of June 1965, there shall be substituted "31st March 1968" in place 5 "31st March 1967" of "31st March 1967".
- 2. This Order may be cited as the Naval Reengagement Grants (Amendment) Order 1967, and may be cited together with the Naval Reengagement Grants Orders 1965 and 1966 as the Naval Reengagement Grants Orders 1965 to 1967.

The Queen's Most Excellent Majesty in Council Whereas by Order in Council dated 10th March 1966 certain rates of pay and allowances were laid down for Her Majesty's Naval and Marine Forces:
And whereas the pay of Royal Naval Medical and Dental Officers was not included:
Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by section 3 of the Naval and Marine Pay and Pensions Act 1865, and

of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. The revised rates of pay in the Schedule to this Order are daily rates and shall apply, subject to the regulations issued by the Admiralty Board of the Defence Council, to Medical and Dental Officers of the Royal Navy and to members of the Royal Naval Reserve while serving or training in Her Majesty's Ships or Establishments. The rates of pay shall not apply to Officers appointed for time only or otherwise holding Naval rank for purposes of status only or to personnel recruited abroad for local service. local service.

2. Increments of pay for Officers of the Royal Naval Reserve shall continue to depend on mobilised service on naval rates of pay in the confirmed rank.

3. This Order may be cited as the Naval and Marine Pay and Pensions (Pay) Order 1967 and shall have effect from 1st October 1966 but the revised rates of pay shall not be payable before 1st July 1967. 1967.
