ROAD TRAFFIC ACT, 1960

The East of Birmingham (Little Packington—Weefo (Prohibition of Waiting) (Clearways) Order 1967 -Weeford)

The Minister of Transport has made the above-mentioned Order under the Road Traffic Act, 1960. The effect of the Order is to prohibit (with certain exceptions) the waiting of vehicles on those lengths exceptions) the warting of vehicles on those lengths of main carriageway specified in the Schedule hereto. It also prohibits trading from the verges of the main carriageways of those lengths of roads.

SCHEDULE

The main carriageways comprised in that length of the trunk road which lies:

In the County of Warwick

1. Between its junction with the A.452 road near Little Packington and its junction with the A.453 at Bassetts Pole, a distance of approximately 10·1 miles.

The Trunk Road (High Street, Needham Market) (Restriction of Waiting) Order 1967

The Minister of Transport proposes to make an Order under section 26 (1), (2) and (3) of the Road Traffic Act, 1960 the effect of which will be that:

No person shall cause any vehicle to wait between the hours of 8 a.m. and 8 p.m. on any day other

than a Sunday

- (i) in either of the lengths or on either of the sides of road specified in Schedule 1 to this notice or
- (ii) on either of the sides of road specified in Schedule 2 to this notice
 - (a) for a longer period than thirty minutes; or (b) if a period of less than thirty minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to the maintenance of the road or the services. traffic, the maintenance of the road or the services
