Ringwood, at the Post Office at Brockenhurst and at the Post Office at Burley, where they may be inspected

during the usual office hours.

On the hearing of the applications the applicant authority, any person to whom notice is required to be given under paragraph (1) of the Twelfth Schedule to the Highways Act, 1959, any person who uses the highway and any other person who would be aggrieved by the making of the Orders applied for shall have the right to be heard.
