FACTORIES ACT 1961 DRAFT SPECIAL REGULATIONS

The Wire Rope (Test and Safe Working Load) Regulations 196

In pursuance of section 180 of, and the Fourth Schedule to, the Factories Act 1961 the Minister of Labour hereby gives notice that he proposes to make Special Regulations imposing requirements for the test and examination of wire ropes before use in factories and certain warehouses, in certain electrical

stations, in certain processes in docks, wharves, quays and ships, in shipbuilding and ship-repairing and in building operations and works of engineering construction. The Regulations also provide for the safe working load of a wire rope for each intended use of the rope to be entered in a certificate before it is so used, and require such safe working loads not to be exceeded.

They supersede similar provisions in the Factories Act, 1961, and in the Docks Regulations, 1925 and 1934, the Shipbuilding and Ship-repairing Regulations, 1960, and the Construction (Lifting Operations) Regulations, 1961.

ROAD TRAFFIC ACT 1960

The Trunk Road (Various Streets, South Molton, Devon) (One-Way Traffic and Prohibition and Restriction of Waiting) Order 1967.
