2. And whereas by section 5 (3) of the Act, but subject to section 5 (4), the Board are required to make their report so as to allow publication within three months of the said date ;

3. And whereas the First Secretary of State and the Minister of Housing and Local Government, in pursuance of their powers under the said section 5 (4), by a direction published in the Gazette on 24th February 1967, extended the said period of three months by three months.

4. Now therefore the First Secretary of State and the Minister of Housing and Local Government, in pursuance of their powers under the said section 5 (4), hereby direct that the said period of three months be further extended by three months.
