PUBLIC SCHOOLS ACT, 1868

2nd June 1967.

THE GOVERNING BODY OF WESTMINSTER SCHOOL having on the 22nd day of May 1967, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And notice is hereby given, that any person, body of persons, or body corporate, authorised in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Westminster School on the 22nd day of May 1967. STATUTE to amend further the Statutes sealed the 17th May 1869 and the 28th July 1871 (as subsequently amended).

We, the Governing Body of St. Peter's College, Westminster, commonly called Westminster School, in virtue of the powers invested in us by the Public Schools Act, 1868, and of all other powers enabling us in that behalf, do hereby make the following Statute amending the Statutes sealed with our Common Seal the 17th May 1869 and the 28th July 1871, as subsequently amended;

STATUTE

- 1. This Statute shall take effect from and after the approval thereof by Her Majesty in Council.
- 2. The words "are Graduates of any English University, and", which appear in Clause 1 of the Statute sealed the 17th May 1869, approved by the Queen in Council on the 7th October 1869, and amended by Orders in Council the 28th June 1875 and the 13th August 1935, shall be deleted.
- 3. The Chapters and Clauses of the Statute sealed with our corporate seal the 28th July 1871, approved by the Queen in Council the 3rd November 1871, and amended by Orders in Council the 26th March 1878, the 26th February 1880, the 19th October 1939, the 2nd June 1948 and the 29th July 1955, which are mentioned in the first column of the Schedule hereto shall be deleted to the extent shown in the scond column thereof.
- 4. (1) The following shall be substituted for the existing Chapter II of the said Statute sealed the 28th July 1871:

CHAPTER II

Under Master

There shall be an Under Master of the School, who shall rank in the School immediately after the Head Master and shall in his absence act as his deputy.

(2) The following shall be substituted for the existing Chapter XI of the said Statute sealed the 28th July 1871:

CHAPTER XI

Investment of Capital Monies

- 1. Any capital monies for the time being in the hands of the Governing Body may be invested by them:
- (1) in the purchase of any freehold land in the United Kingdom or any leasehold land in the United Kingdom held upon a lease or underlease having not less than 50 years' unexpired, with power (with the consent of the Secretary of State for Education and Science when so required by law) to sell, assign, lease or mortgage any such land aforesaid.
- (2) in any investments for the time being authorised by law for the investment of trust funds.

Provided that for the purposes of this Statute the Trustee Investments Act 1961 or any statutory modification or re-enactment thereof for the time being in force shall take effect as if

(i) section 2 (1) thereof required as a condition precedent to the exercise of the powers conferred by section 1 thereof the division of the fund into two parts, the parts being as to narrower-range investments one third of the whole and as to wider-range investments two thirds of the whole; and
(ii) there were authorised by Parts III and IV of the First Schedule thereto any of the following investments that is to say
