REPORT OF THE NATIONAL BOARD FOR PRICES AND INCOMES

Pay and Conditions of Merchant Navy Officers

On 26th April 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Labour referred the question of the pay and conditions of Merchant Navy Officers to the National Board for Prices and Incomes for examination.

The Board has now made its report and in accordance with section 5 (1) of the Prices and Incomes Act 1966 the First Secretary of State and the Minister of Labour hereby give notice that the report was first published as Command Paper Number 3302 on 2nd June 1967.

TOWN AND COUNTRY PLANNING ACT 1962
