## CLEETHORPES BOROUGH COUNCIL

*The Borough of Cleethorpes (Coronation Road) (One-Way) Order, 1967*

## GRIMSBY COUNTY BOROUGH COUNCIL

*The County Borough of Grimsby (Scartha Village) (Traffic Regulation) Order, 1966 (Amendment No. 1) Order, 1967*

Notice is hereby given that on the 2nd June 1967, the Grimsby County Borough Council made an Order under Section 26 of the Road Traffic Act, 1960, the effect of which is:

1. To prohibit the waiting of vehicles on the length of road specified in the First Schedule hereto between the hours of 8 a.m. and 6 p.m. on all days except Sunday.
2. To restrict the waiting of vehicles on the length of road specified in the Second Schedule hereto to a maximum of thirty minutes in any one hour between the hours of 8 a.m. and 6 p.m. on every day except Sunday.
3. To prohibit the loading or unloading of goods from vehicles on the length of road specified in the Third Schedule hereto between the hours of 8 a.m. and 6 p.m. on all days except Sunday.

The usual exemptions to permit the waiting of vehicles for certain specified purposes will apply.

The provisions of any orders which are contrary to these proposals or by which these proposals were formerly operated are revoked.

The Order will be effective as from 8 a.m. on Tuesday the 6th June 1967.
