### TREASURY

Treasury Chambers, London S.W.1.  
7th July 1967.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 14th July 1967, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 17th July to Saturday the 22nd July 1967, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958, viz.:

The Import Duties (Temporary Exemptions) (No. 5) Order 1967.

This Order provides that the goods listed in Schedule 1, chemicals, shall be temporarily exempt from import duty, and those listed in Schedule 2, including chemicals and certain other goods, shall continue to be temporarily exempt from import duty until 30th December 1967, or such other date as may be specified in the Order.

The Order comes into operation on 6th July 1967 and has been published as Statutory Instruments 1967 No. 979.

#### THE PRICES AND INCOMES ACT 1966

Notice under section 29

The Secretary of State hereby gives notice that he is considering the making of an Order under sections 25(5) and 29 of the Prices and Incomes Act 1966, in the terms set out at the end of this notice, revoking the Temporary Restrictions on Pay Increases (20th July 1966 Levels) (No. 1) Order 1966 (S.I. 1966/1365), and the Temporary Restrictions on Pay Increases (20th July 1966 Levels) (No. 5) Order 1967 (S.I. 1967/424) being Orders made by the Secretary of State under the said section 29 respectively on 1st November 1966 and 20th March 1967 which imposed restrictions on increases in remuneration for work performed respectively under certain contracts of employment by employees of Thorn Electrical Industries Limited and by persons employed in certain capacities by Birmingham Corporation in their Transport Department.

Any employer, or any employers' organisation, trade union, trade union organisation or other person representing employers or employees may make representations as respects the proposed Order in writing to the Secretary of State addressed to the Department of Economic Affairs, Storey's Gate, London S.W.1, within 14 days from 7th July 1967.

After the expiration of that period, and subject to consideration of any representations duly made, the proposed Order may be made in the following terms:—
