The QUEEN has been graciously pleased on the advice of Her Majesty's Australian Ministers to approve the undermentioned awards in recognition of gallant conduct in Vietnam:

To be dated 27th July 1967

Distinguished Service Order

Lieutenant-Colonel Colin Maurice TOWNSEND (17000), Australian Staff Corps.

Lieutenant-Colonel Townsend has commanded with outstanding success the 6th Battalion, The Royal Australian Regiment, since its deployment in Vietnam in May 1966. During this period he planned and executed the initial forward deployment of his battalion into enemy controlled territory, an aggressive and extensive patrol programme and eleven battalion group offensive operations. After seven months of almost continuous contact with an effective and fanatical enemy his battalion has inflicted 318 confirmed enemy casualties together with extensive damage in terms of captured weapons, ammunition, food and installations.

During the battle at Long Tan during 18th to 21st August 1966, his battalion constituted the infantry element in the action against a regiment composed of three North Vietnamese and Viet Cong main force battalions. As soon as the initial heavy contact with the enemy was made by his company on patrol he moved immediately with a relief company in armoured personnel carriers to join his company which was then very heavily committed and took firm and effective control of the battle during which a major defeat was inflicted on a greatly superior enemy force.

Throughout this period, Lieutenant-Colonel Townsend's spirit of aggression and sound tactics and his courage under fire and calm leadership have been an inspiration to his battalion and to all who have served with him. He personally has been largely responsible for the heavy damage inflicted by his battalion on the enemy at the expense of relatively light own casualties and for the driving of the enemy force from Southern Phuoc Tuy Province.

Military Cross

Major John Matthew MURPHY (335048), Australian Staff Corps.

Major Murphy has commanded the 3rd Special Air Service Squadron since its deployment in operations in Vietnam in June 1966. Throughout this period of six months his small reconnaissance patrols and fighting patrols have carried out the very hazardous task of extensive patrolling deep into enemy territory to gain invaluable information on which the successful offensive operations of the Australian Task Force have been based. In addition his patrols when in contact with greatly superior enemy forces deployed to hunt them have by skilful and sudden aggressive action inflicted very significant casualties on the enemy and extricated themselves by helicopter from many very dangerous situations to complete their missions.

During 1st and 2nd December 1966 his squadron was given the task of checking the effectiveness of operations to deny the use of the base facilities in the Nui Thi Vai mountain mass to the enemy after our troops had had to leave the area. Major Murphy without hesitation undertook this mission himself and over the period of two days reconnoitered the area by lowering repeatedly to the rocky and jungle covered slopes hanging from a winched cable some 150 feet under a hovering helicopter and exposing himself to enemy fire. His mission was completely successful.

On 14th December he planned and led a heliborne raiding party into the heart of an enemy base area

to blow up a 150 foot concrete tower which the enemy had been using as an observation post equipped with radio. Again the highly hazardous mission was completed with outstanding success and was typical of similar operations which he has led personally.

Major Murphy, throughout his service in Vietnam, has by personal example, leadership, courage and sound planning inspired his squadron to achieve outstanding success.

2nd Lieutenant John Douglas McALONEY (38050)
Australian Staff Corps.

On 18th October 1966, during Operation Quenbeyan in Phuoc Tuy Province, South Vietnam, Second Lieutenant John Douglas McAloney commanding the Assault Pioneer Platoon of Fifth Battalion, The Royal Australian Regiment, was given the difficult task of clearing booby traps from a rocky, thickly jungled, cave riddled spur. The area was the scene of a bitter engagement between other elements of Fifth Battalion, the Royal Australian Regiment, and the Viet Cong on the preceding day during which the enemy had withdrawn deeper into the protection of the booby trapped caves. The clearance of the booby traps was to precede a detailed search of the caves. After positioning covering groups, Second Lieutenant McAloney, alone, entered the first cave entrance to commence delousing the booby traps. At this time, a Viet Cong sniper fired from another concealed cave entrance mortally wounding one of the Assault Pioneer sentries. With complete disregard for his own safety, Second Lieutenant McAloney moved from the shelter of the cave out to the wounded man and dragged him to a more secure area. After arranging for the evacuation of the casualty, Second Lieutenant McAloney, alone, again approached the suspect cave and personally tossed gas grenades into both the front entrance and possible exits. As the gas and subsequent firing of M79 grenades into the cave still failed to dislodge the occupants, preparations were made to employ flame throwers. Firstly Second Lieutenant McAloney again moved out alone under covering fire to recover the weapon of the wounded man. This was lying in the line of fire for the proposed flame attack. Whilst doing this he was wounded in the right temple but persevered and retrieved the weapon. He then gathered a flame thrower team of two men and personally led them in a frontal flame assault on the caves area, burning out each entrance in turn. The personal courage and leadership shown by this officer throughout the three and one half hour period of the action was of the highest order. His determination to close with and destroy an experienced and concealed enemy; in extremely difficult terrain was an inspiration to all ranks.

2nd Lieutenant Michael Gunther Joseph DEAK (216701), Royal Australian Infantry Corps.

On 17th October 1966, during Operation Quenbeyan in Phuoc Tuy Province, South Vietnam, Battalion Headquarters of Fifth Battalion, Royal Australian Regiment was held up by Viet Cong in a natural ambush position on a steep mountain track. The Anti-Tank Platoon commanded by Second Lieutenant Deak was directed to clear the area. The enemy were located in natural fire positions on both sides of a deep re-entrant with a gradient of one in two. One section of the platoon covered by the remainder swept up the re-entrant but the Section Commander was mortally wounded and the remainder pinned down by fire.

Second Lieutenant Deak re-deployed the remainder of his platoon and under fire directed additional covering fire on to the objective from another company 800 metres away. He then successfully directed the fire of armed helicopters on to the enemy positions and then led his platoon back into the re-entrant and cleared the enemy position without loss.

At all times during the three and one quarter hours engagement, Second Lieutenant Deak showed complete disregard for his own safety even when it became apparent that the enemy were concentrating their fire on leaders. The calm and competent manner of Second Lieutenant Deak was a major factor in steadying his platoon under fire in a difficult situation. The success in clearing the Viet Cong ambush position was due in the main to the fine example of leadership and courage set by Second Lieutenant Deak.

2nd Lieutenant Dennis Claude RAINER (54624), Australian Staff Corps.

On 21st October 1966 Second Lieutenant Rainer was in command of 10 Platoon D Company on a routine search and destroy patrol in the Nui Thi Vai hills of Phuoc Tuy Province South Vietnam.

His platoon was searching a foot track, when the forward elements came upon a small rice cache and then a suspected enemy sentry post. Shortly afterwards, he saw a complex of three huts, set in an extremely rocky and steep re-entrant. He deployed a section in a wide sweep to the right and led two sections astride the main track. All members had to move carefully through bamboo panjis which surrounded the area. He could hear voices and smell food and fires. At this stage he had no idea of what was in the village; however he crawled forward with his two sections, to within 15 feet of the largest hut.

The right hand fire support section opened fire. Immediately, approximately ten to twelve enemy fled out of the large hut. They ran into the fire of the assault section and when the firing ceased, the platoon had killed ten enemy. Approximately four enemy fled away from the fire and escaped to the East. No casualties were sustained in his own platoon.

The success of the contact highlighted the degree of professional proficiency that Rainer has attained with his platoon. His platoon strength was only slightly larger than the number of the enemy; however quite fearlessly he deployed his men in what proved to be a perfect ambush.

Distinguished Conduct Medal

38317 Trooper (Temporary Corporal) John Alexander CARTER, Royal Australian Armoured Corps.

At approximately 1800 hours 18th August 1966 Corporal John Carter was the Crew Commander of an armoured personnel carrier of 3 Troop First Armoured Personnel Carrier Squadron. This troop had been given the task of carrying a relieving force of Infantry to assist D Company 6 Battalion Royal Australian Regiment which was in heavy contact with a brigade sized enemy force. Orders were for the carrier troop to advance with two sections forward. Weather conditions at the time were extremely difficult due to a severe rain storm.

When contact was made with the enemy, Corporal Carter's vehicle was engaged by fire from a 57 millimetre recoilless rifle, machine gun and small arms fire. The projectile from the 57 recoilless rifle missed his vehicle and exploded against a rubber tree. Corporal Carter returned the fire using his 50 calibre machine gun. The gun jammed. He then grasped the driver's Owen Machine Carbine and without hesitation leapt on to the top of his vehicle and returned fire killing the 57 millimetre recoilless rifle team a fraction after another 57 millimetre recoilless rifle round had been fired. This round exploded and dazed the crew and passengers. Corporal Carter still undeterred continued to fire killing five other enemy.

By his actions Corporal Carter also drew additional fire on to himself enabling the other vehicles of the troop to advance.

Through the action which was fought at very close range, Corporal Carter showed outstanding courage, initiative and determination. His actions were an inspiration to all his comrades and contributed greatly to the success of the assault by the relief force, the heavy casualties inflicted on the enemy, and, immediately afterwards, the relief of D Company 6 Battalion, The Royal Australian Regiment.

Military Medal

16181 Sergeant (Temporary Warrant Officer Class II) Brian Donald CLARK, Royal Australian Infantry Corps.

Warrant Officer Brian Donald Clark, Royal Australian Infantry, enlisted in the Australian Regular Army on 13th June 1961 and since that date he has served with 3rd and 7th Battalions, Royal Australian Regiment.

In 1964 and 1965, he was engaged on operational duties in Borneo, Malaysia. Warrant Officer Clark volunteered for service in Vietnam and, on 19th September 1966, joined the Australian Army Training Team. He was posted as an adviser to 3rd Battalion, 6th Regiment, 2nd Infantry Division, Army of the Republic of Vietnam.

On 14th December 1966, the 3rd Battalion was occupying an outpost position in the vicinity of Tam Ky, in Quang Tin Province, South Vietnam, Warrant Officer Clark together with two United States Army Advisers occupied a bunker within the outpost.

At 0100 hours, the outpost was attacked by a Viet Cong force approximately 100 strong, who successfully penetrated the position. Using grenades and explosive charges the Viet Cong disrupted the main defensive position, including destruction of the adviser's and the Vietnamese Battalion Commander's bunkers. They directly threatened the two 105 mm howitzers in situ. They were repulsed only after approximately three hours fighting and after friendly artillery had been called onto the position.

Warrant Officer Clark personally engaged a number of Viet Cong with his rifle and personally protected one of the 105 howitzers with his fire, saving it from being blown up, despite counter enemy action by grenades and small arms fire. Throughout the defensive artillery fire on the outpost, he maintained his position in the open and continued to engage the enemy. Later he found and assisted the seriously wounded battalion senior adviser. He returned to his then burning bunker to gain materials to make the patient comfortable. He retrieved a wireless set and a box of grenades from the burning bunker, notwithstanding the obvious danger to his person. The only adviser remaining in fit condition, Warrant Officer Clark then proceeded to help the Battalion commander reorganise the position and mop up, whilst secondary explosions from stacked artillery ammunition on the position occurred intermittently. At 0630 hours Warrant Officer Clark worked at clearing a helicopter landing zone on the position involving movement of heated suspect grenades and 105 artillery ammunition, so that casualties could be evacuated quickly. In doing so he saved the lives of a number of badly wounded soldiers who may otherwise have died. In the action, 55 Viet Cong were killed whilst 78 Vietnamese were killed and wounded and two U.S. Advisors wounded.

Throughout the action Warrant Officer Clark exhibited a calm and deliberate manner, continued correctly to evaluate the situation and personally thwarted the enemy in their endeavours, especially against one artillery piece which he doubtless saved from destruction. His actions contributed positively to the defence of the position, to the repulse of the enemy and to saving friendly lives. His personal bravery was sustained in the face of a resolute enemy and extreme danger from exploding shells, and grenades over a four to five hour period. His personal bravery, professionalism and devotion to duty in this action were outstanding and were in keeping with the highest traditions of military service reflecting great credit on himself, the Advisory effort and the Australian Regular Army.

1410219 Sergeant (Temporary Warrant Officer Class II) James STEPHENS, Royal Australian Army Service Corps.

1410219 Warrant Officer Class II James STEPHENS, Royal Australian Army Service Corps, re-enlisted in the Australian Regular Army Special Reserve in 1956. Following a series of Corps postings, he volunteered for service in South Vietnam and in April 1966 joined the Australian Army Training team, being posted as assistant advisor to the 1st Battalion, 5th Regiment, 2nd Division, Army of the Republic of Vietnam.

On 6th November 1966, 1st Battalion was engaged in a clearing operation in Quang Tin Province and Warrant Officer Stephens accompanied the battalion. The battalion was the main assault force for an attack by 5th Regiment. At approximately 1615 hours as the assault progressed, the battalion was counter attacked from both left and right flanks by an estimated Viet Cong Company employing small arms, automatic weapons, mortar and recoilless rifle fire. It was halted by fire from the objective area, and began to break and fall back. The command group, with which Warrant Officer Stephens was located, became exposed on one flank.

Exposing himself to heavy hostile fire Warrant Officer Stephens by using drive, determination and outstanding individual example of disregard for personal danger formed a defence with the troops around him, and then formed a covering force and directed effective fire on to the enemy. By so doing he was directly responsible for minimising friendly casualties, and his achievement allowed some semblance of orderly movement to the rear by the

remaining troops to take place. Forced to withdraw, he was again outstanding in his endeavours to reform and reorganise the battalion into a defence posture, even though it was still under heavy fire. He maintained a calm and professional demeanor throughout this phase and was largely responsible for the Unit remaining a viable force, available for further employment later in the operation.

Warrant Officer Stephens showed outstanding courage, professionalism and devotion to duty with complete disregard for his personal safety, throughout the entire engagement. His personal bravery was an inspiration to the Vietnamese and was beyond the normal call of duty. His conduct on the 6th November 1966, was in keeping with the highest traditions of Military Service and brought great credit to himself and the Australian Regular Army.

15437 Corporal (Temporary Sergeant) Emanuel Lejorio Antonio TONNA, Royal Australian Infantry Corps.

Sergeant Tonna has been a Special Air Service patrol commander in South Vietnam since June 1966. During this period he has led his patrols on numerous occasions deep into Viet Cong dominated territory. Of these patrols, six culminated in clashes with the enemy resulting in four enemy killed in action, two wounded and one captured. Sergeant Tonna has also been the subject of a friendly air strike.

All Sergeant Tonna's patrols have been extremely successful and his reporting of enemy activity has been accurate and detailed. His coolness under fire, his quiet determination and his thoroughness have made him an outstanding patrol commander and a fine example to the whole of the Squadron. His overall approach to hazardous patrolling is in the finest tradition of the Special Air Service Regiment and the Royal Australian Infantry Corps.

214031 Corporal Robin William JONES, Royal Australian Infantry Corps.

On the 17th February 1967, Sixth Battalion, The Royal Australian Regiment engaged an enemy force near Lang Phuoc Hai, in Phuoc Tuy Province, in the Republic of South Vietnam. Corporal Robin William Jones was a Section Commander in B Company.

In the middle of the afternoon B Company assaulted a defensive position manned by a well-trained, well-led Viet-Cong force equipped with heavy machine guns, mortars and recoilless rifles. During the assault, heavy fire was directed at the company from both flanks and the left flank became pinned down. Corporal Jones' section carried out an immediate assault on the right flank and engaged the enemy at close range with grenades and small arms fire, and inflicted heavy casualties on them. At this stage three previously unlocated enemy machine guns opened fire causing severe casualties to the section. Corporal Jones displayed excellent leadership and skill in directing covering fire, and re-organising his section under the intense fire which included mortars, claymore mines and grenades.

With every man in his section killed or wounded Corporal Jones' actions contributed greatly to restoring the security of the right flank of the company and resisting the enemy counter-thrusts which developed.

Throughout the action Corporal Jones demonstrated leadership, personal courage and devotion to duty of an exemplary nature.

4717624 Private Peter FRASER, Royal Australian Infantry Corps.

On 17th October 1966, during Operation Quenbeyan in Phuoc Tuy Province, South Vietnam, the Anti-Tank Platoon Fifth Battalion, The Royal Australian Regiment, was directed to clear a Viet Cong ambush. During the clearing a section commander was mortally wounded by a sniper and fell in an exposed position. Heavy enemy fire prevented movement of any members of the section. Private Fraser, the stretcher bearer attached to the Anti-Tank Platoon, was told by the platoon commander not to go forward to the casualty until the area had been cleared. Private Fraser however crawled forward under fire, reached the casualty and dressed the wound. Whilst Private Fraser was with the casualty a sniper concentrated his fire on Private Fraser and with the fire falling only inches from him, Private Fraser continued to assist the casualty.

The Platoon Commander then arranged for covering fire to be given by the remainder of the platoon

at which time Private Fraser turned his back on the enemy fire to shield the casualty from fire and assisted a carrying party to evacuate the casualty.

During the extraction of the casualty Private Fraser showed complete disregard for his own safety in an effort to give maximum attention to the care of the casualty.

16646 Private Richard Beverley ODENDAHL, Royal Australian Infantry Corps.

On the 17th February 1967, Sixth Battalion, The Royal Australian Regiment engaged a large enemy force near Lang Phuoc Hai in Phuoc Tuy Province in the Republic of South Vietnam. Private Richard Beverley Odendahl was the stretcher bearer attached to 5 Platoon B Company.

In the middle of the afternoon B Company assaulted a defensive position manned by a well trained, aggressive Viet-Cong force which was equipped with heavy machine guns, mortars and recoilless rifles.

During the assault 5 Platoon suffered fourteen casualties, all of whom were lying in an area swept by machine gun fire, and into which snipers were directing well aimed fire. Showing complete disregard for his own safety Private Odendahl moved forward into the area and carried or dragged a number of the wounded back to an area out of the direct fire of the machine guns. Although under continuous fire from the enemy he assisted and treated the wounded for over three hours until their evacuation was completed.

Throughout the action Private Odendahl's total lack of concern for his own personal safety was an inspiration to the whole company. But for his determination, courage and selfless devotion to duty many of the wounded treated by him may have died.

Military Cross

Captain David Brian Wynn WEBB-CARTER (467644) Irish Guards.

Captain Webb-Carter, who had arrived from England only a few days before, was acting as Commander of his Company at Wadi Matlah camp on the night of 30th December 1966, since his Company Commander was on a detached operation. The Camp was a temporary one and necessarily in a rather exposed position.

At about 2200 hours, the camp was suddenly brought under intensive small arms, mortar, grenade and blindicide fire from a band of dissidents. Later it was discovered that this band numbered 35 to 40 and were firing from positions on two sides of the camp.

He was in the Company Command Post at the time of the attack. He immediately ran out across an open stretch of sand, which was by then being raked by small arms fire and raced up to a picquet position on the exposed side of the camp. Here by personal observation he ascertained the direction and position of the enemy. He then co-ordinated all available fire to be directed on to the enemy with the maximum effect and minimum delay.

The action continued and during it Captain Webb-Carter frequently left the comparative safety of his Command Post to visit positions under fire in order to encourage platoons and to acquaint himself with the enemy situation. Each time he did this he had to cross an open space of light coloured sand on which the shadow of any movement was very visible. He crossed this space four or five times during the engagement each time attracting heavier and heavier fire.

While maintaining control of the battle, he managed to find time to send sensible situation reports to his Battalion Headquarters to whom it was obvious at the time that his control of the situation was excellent. The enemy pressed the attack by firing on the camp for over an hour in all—an unusually sustained attack for the Radfan and undoubtedly suffered casualties as a result of No. 3 Company's counter fire.

His personal actions contributed greatly to the successful defence of the camp and to the discomfort of the enemy. His constant presence when needed and complete coolness under fire, as well as his total disregard for his own safety and his evident mastery of the situation, was an inspiration to everyone under his Command.

Most of those under his command were under fire for the first time and they owed a great deal to his courage, calm assurance and fine leadership, which more than measured up to that of a vastly more experienced officer.

Air Force Cross

Major Greville John Brooks EDGECOMBE (426867) Army Air Corps.

At approximately 0200 hours on 19th February 1967, following a dissident attack on Dhala, a request was made to Headquarters Area West in Habilayn, to arrange casualty evacuation for two Priority One cases—one a Mulazzim of the Federal Regular Army, the other a Marine of 45 Commando Royal Marines. Both men had been very severely wounded and the Medical Staff considered that their chances of surviving the night were very slight unless they were evacuated as soon as possible.

Major Edgecombe, Officer Commanding 8 Flight Army Air Corps, was asked if he would attempt the evacuation though a night evacuation from either the British or Federal Army camps at Dhala had never been achieved before. At Habilayn there was complete cloud cover but a weather report from Dhala revealed that, though some cloud could be seen moving across the plain, there was no cloud over Dhala itself. In spite of the adverse weather and the fact that there was no moon, Major Edgecombe, with his customary selfless approach to his duties, decided to make the attempt using a dual control Scout helicopter with Captain Grist as second pilot. The Scout helicopter is equipped with radio, and a full instrument panel, but it has no avionic navigation equipment; the pilot therefore has to rely entirely on a bearing and distance calculation. Between Habilayn and Dhala the country is very mountainous and the ground rises from 2,000 feet to 4,500 feet with several intervening peaks of 5,000 to 5,500 feet. For any small aircraft night flying in the area is always extremely hazardous even under good weather conditions.

After taking off from Habilayn, Major Edgecombe flew his aircraft through 1,000-1,500 feet of cloud until he was able to obtain some horizon even though only from the stars and cloud below him. He had asked for assistance from the radar at Royal Air Force Khormaksar but they were unable to see him on their screen. After about 15 minutes flying a descent was made towards the British camp at Dhala where the troops had positioned four Gooseneck Flares and an Angle of Approach Light, but the final approach had to be made between two dark hills into a small pad surrounded by sandbags. This was difficult. A landing in the Federal Regular Army camp would have been impossible and it was therefore necessary for the aircraft to wait on the pad whilst the Mulazzim was brought to the British camp; it was a slow journey. Dissident fire had ceased some time before but movement around the camp continued to be reported and the British troops kept up harassing fire to discourage further movement or an attack on the aircraft.

The journey to Aden was some 50 miles. Once more Major Edgecombe flew his aircraft above the mountains and the clouds and kept on this course for the next 30 miles. When clear of the mountains he then had to make a descent through the clouds, which had by now thickened to some 2,500 feet, and eventually landed his casualties on the helicopter pad outside the main entrance to Khormaksar Beach Hospital.

Major Edgecombe is an experienced pilot and he was therefore fully aware of every hazard he was facing and every risk he was taking. They were both considerable. That such a difficult flight was

successfully accomplished says much for his outstanding skill as a pilot. He undoubtedly made a major contribution in saving the lives of two men, who though still in hospital, are now making a recovery.

Distinguished Flying Medal

23654083 Sergeant William POLLARD Royal Regiment of Artillery.

During the past twenty-one months Sergeant Pollard has flown as a Sioux helicopter pilot of the Air Observation Troop, 1st Regiment Royal Horse Artillery. The greater part of his tour has been in support of counter-dissident operations in the mountain and desert areas of the Radfan and surrounding districts of South Arabia, where combinations of altitude, temperature and ever varying wind conditions, confront any pilot, and particularly a light helicopter pilot, with some of the most hazardous flying to be encountered anywhere in the world.

Apart from his normal tasks of reconnaissance and control of artillery fire, he has carried out many casualty evacuation sorties, some of them under direct enemy small arms fire. On 28th June 1966, when supporting an operation near the Yemen border, Sergeant Pollard observed a camel train which appeared to him to be acting in a suspicious manner. Manoeuvring into dead ground, he worked forward into a position from where he saw the camels being hurriedly unloaded by armed men, who started to run towards the border. He promptly called up troop-carrying helicopters to cut off the dissidents, and in the resulting action three dissident tribesmen were killed.

On 16th November 1966, he was required to move a picquet of D Company 2nd Parachute Battalion into a position overlooking a Wadi. As he landed for the picquet to deplane, he came under fire and his helicopter was hit by a rifle bullet which passed between his head and the port fuel tank, missing both by about one inch.

Undisturbed by his narrow escape, and ignoring the likelihood of further damage to himself or his aircraft, Sergeant Pollard located the dissidents who were now engaging the British company area. He radioed for artillery support and directed the gun fire with successful, and effective results.

In recent operations Sergeant Pollard's aircraft has been hit three times by enemy small arms fire. Among both British and Federal forces he has earned a reputation for skill, initiative and determination in carrying out his operational sorties, which goes far beyond that expected of a young and relatively inexperienced non-commissioned officer pilot.
