### HIGHWAYS ACT, 1959

*Samford Rural District Council (Footpaths No. 25 and No. 26 (Parts)) Shotley Public Path Diversion Order 1967.*

Notice is hereby given that the Minister of Housing and Local Government in pursuance of his powers under section 112 of the Highways Act 1959, after consultation with the Samford Rural District Council proposes to make an Order for the diversion of Parts of Footpath No. 25 and No. 26 at Shotley in the county of East Suffolk.

The draft Order relates to land situate in Shotley; the effect of the Order will be to divert parts of the public right of way over Footpath No. 25 and Footpath No. 26, which part of Footpath No. 25 starts at the south-eastern corner of Rose Farm Cottages and runs generally west along the sea shore to its junction with Footpath No. 26 which continues west along the sea shore to the south-western corner of the aforementioned cottages, an approximate distance of 183 yards; to a line starting at the aforementioned point at the south-western corner of Rose Farm Cottages and running north for a distance of approximately 28 yards and then continuing east along the northern boundary of the aforementioned cottages for a distance of approximately 177 yards to its junction with an existing right of way.
