St. James's Palace, London S.W.1. 8th August 1967.

The Queen has been graciously pleased, on the advice of Her Majesty's Canadian Ministers, to approve the award of the British Empire Medal for Gallantry (Military Division) to the undermentioned:

Leading Seaman Doyle Clement White, 44253—H Royal Canadian Navy.

At approximately 2030 hours on 18th October 1965, while at sea, two explosions occurred in 12 Mess on H.M.C.S. Nipigon. The force of these explosions blew the locked cover off a tank containing JP 5 helicopter fuel causing a flash fire in the Mess. The coinpartment directly above the Mess contained ammunition. At the time of the explosions there were eleven men in 12 Mess, one of which was Leading Seaman White. Although burned about the face and hands when escaping from the Mess, Leading Seaman White rushed to the Quartermaster's lobby to inform the lifebuoy sentry of the explosions in order that Command could be informed. He then returned to the area of the Mess to assist where needed but when advised that one man who appeared to be unconscious had not escaped from the Mess, immediately donned a set of breathing equipment and eventually donned a set of breathing equipment and with fumes from the JP 5 fuel and heavy black smoke. Freeing the unconscious man Leading Seaman White, with the assistance of Able Seaman Gray who had just entered, carried the man to the foot of the hatch and then searched all bunks to ensure no one else was trapped. Then with the assistance of the Able Seaman and other crew members, brought the man up to the mortar well on the deck above. Leading Seaman White then assisted the damage control parties in flooding the JP 5 fuel tank with sea water and the removal of smouldering material. Although burned by the initial flash fire, Leading Seaman White alerted Command, re-entered the fume and smoke filled Mess to rescue a comrade, and did excellent work in a dangerous area which contained an open JP 5 fuel tank adjacent to stored ammunition before obtaining medical attention for himself. This fine display of courage in the face of serious injury or possible death, is a credit not only to Leading Seaman White, but also his ship and the Canadian Forces.

Able Seaman Wendell Tolson Gray, 49957—H Royal Canadian Navy.

At approximately 2030 hours on 18th October 1965, while at sea, two explosions occurred in 12 Mess on H.M.C.S. Nipigon. The force of the explosions blew the locked cover off a tank containing JP 5 helicopter fuel causing a flash fire in the Mess. Directly above the Mess was a compartment containing ammunition. At the time of the explosions, Able Seaman 'Gray was in the main cafeteria. Immediately making his way to the upper deck he was instructed by the Damage Control Officer to break out all available breathing equipment. When informed that Leading Seaman White had entered the Mess to free an unconscious man, he quickly made adjustments to a set of breathing equipment, donned same, and following the Leading Seaman into the Mess, assisted in the evacuation of the man to the mortar well on the deck above. The Mess at this time was filled with fumes from the JP 5 fuel and heavy smoke. Returning to the area, Able Seaman Gray entered the Mess on three successive occasions with fire fighting and other equipment and easisted the damage control parties in clearing the Mess of the smouldering material. Although the youngest man in the group, Able Seaman Gray assisted in the rescue of a comrade, entered the Mess on several occasions where there was an open JP 5 fuel tank, and assisted the damage control parties with the fire-fighting and removal of smouldering materials. His actions throughout this incident, in the face of serious injury or possible death, have brought credit not only to himself, but also to his ship and the Canadian Forces.

On 29th March 1967, Corporal Constable was the Non-Commissioned Officer on duty in the throwing

bay during a live grenade throwing practice at Singleton Barracks.

During the practice a recruit dropped a grenade in the throwing bay after the safety pin had been withdrawn. Corporal Constable, being aware of the danger, bodily threw the recruit out of the bay. The recruit's reaction was slow, and Corporal Constable immediately threw himself on top of the recruit, thereby shielding him from the full blast of the exploding grenade. Corporal Constable himself received the major portion of the blast and was injured by grenade fragments.

Corporal Constable displayed a high standard of initiative, coolness and brave conduct in immediately removing the recruit from the throwing bay. He then showed great courage, foresight and devotion to duty in shielding, with his own body, the recruit from the full blast of the grenade.

Sapper Steven 215029 William Little, Royal Australian Engineers.

On 5th October 1966, Sapper Little was driving a 40 ton tank transporter carrying a bulldozer along the Bruce Highway, Queensland, when two of the trailer tyres blew out. While the corporal in charge and co-driver were away reporting to their unit and arranging for replacement tyres, Sapper Little remained with the vehicle, parked on the side of the road near a sugar cane field.

Shortly after the departure of his two colleagues, Sapper Little saw flames coming from under the front of the trailer. After an unsuccessful attempt to extinguish the fire he noticed that four tyres were burning fiercely. He therefore turned his attention to saving the heavy load, but because of heat and the flames was unsuccesful in his first attempt to

disconnect the prime-mover.

He saw flames enveloping a 44 gallon drum of dieseline on the trailer. Because of the imminent danger of an explosion and disregarding the consequences, he managed to free the drum and remove it out of danger. He then turned his attention to the bulldozer chained on to the trailer. He unchained it, started it up and drove it off the trailer. After a second unsuccessful attempt to disconnect the prime-mover he commenced to cut a fire-break with prime-mover he commenced to cut a fire-break with prime-mover he commenced to cut a fire-break with the bulldozer since the fire was spreading through the grass to the sugar cane. Sapper Little then noticed that the flames had spread to the prime-mover. He again tried to disconnect it, but was driven back by heat and flames. By starting the prime-mover and moving the vehicle forward he was able to get it to a position where the flames blew away from it, then he was finally able to disconnect it and move it to safety. He then returned to cutting the fire-break, by which time the flames had reached the sugar cane and the Nambour Fire Brigade had arrived and taken charge.

With complete disregard for his own safety, unaided, and by his courageous act, Sapper Little was responsible for preventing military equipment valued at over \$45,000 from being completely

destroyed.
