## TOWN AND COUNTRY PLANNING ACT 1962

*Attenborough, Notts*

The Minister of Transport hereby gives notice that she proposes to make an Order under section 153 of the above Act to authorise the stopping up of a length of footpath at Attenborough, Notts, to enable residential development to be carried out in accordance with planning permission granted to W. Westernman Ltd.

The proposed Order will require the provision of a new footpath maintainable at the public expense, for which the highway authority is to be the Beeston and Stapleford U.D.C., and of another new highway.
