SCHEDULE 1

1. *Sides of the Shrewsbury—Dolgelley Trunk Road (A.458), at Welshpool in the County of Montgomery.*

1. The north side of that length, known as Mount Street and Raven Street, which extends from a point 29 yards west of its junction with Chapel Street to a point 181 yards west of that junction, a distance of 152 yards.

2. The south side of that length, known as Mount Street and Raven Street, which extends from a point 23 yards west of its junction with Church Lane to a point 202 yards west of that junction, a distance of 179 yards.

2. The south side of that length, known as Mount Street, High Street and Broad Street which extends from a point 23 yards west of its junction with Church Lane to a point 23 yards north-west of its junction with that length of the Swansea—Manchester Trunk Road (A.483), known as Berriew Street, a distance of approximately 439 yards.
