CLEAN AIR ACT, 1956

County Borough of Stockport (Portwood/Newbridge Lane) Smoke Control Order, 1967

Notice is hereby given that the Stockport County Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 1st day of August 1967, made an Order entitled the County Borough of Stockport (Portwood/Newbridge Lane) Smoke Control Order, 1967, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the omission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st day of June 1969, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the Town Clerk (Room 44), Town Hall, Stockport, at all reasonable times during the period of six weeks from the 21st September 1967.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

SCHEDULE

Commencing at the junction of Middle Hillgate and Waterloo Road, thence along the centre of Waterloo Road to the junction with Upper Brook Street, along the centre of Upper Brook Street to Hawfield Street, thence along Hawfield Street to the junction of Hall Street and Turncroft Lane, thence along the centre of Turncroft Lane as far as the Woodbank Park boundary, thence along the perimeter of the parkland as far as the County Borough boundary (River Goyt), along the centre of the River Goyt as far as the Bredbury Railway Line and from there across to the River Tame, thence along the River Tame as far as the railway line at Tiviot Dale station, thence along the railway line to Lancashire Hill and then along the centre of Lancashire Hill, Tiviot Dale and Bridge Street as far as Lancashire Bridge, thence along the centre of Warren Street to Corporation Street and thence along the centre of Corporation Street to Millgate, thence along Millgate to the Market Place, thence along the centre of Churchgate to Wellington Street, thence along the centre of Wellington Street to Lower Hillgate, thence along the centre of Lower Hillgate to join Waterloo Road.
