LONDON WEIGHTING IN THE NON-INDUSTRIAL CIVIL SERVICE

Direction under Section 5 (4) Further Extending the Period within which the National Board for Prices and Incomes Must Publish Their Report.

Whereas the First Secretary of State and the Chan-cellor of the Exchequer, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act of 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 21st March 1967;

2. And whereas by section 5 (3) of the Act, but subject to section 5 (4), the Board are required to make their report so as to allow publication within three months of the said date; 3. And whereas the First Secretary of State and the Chancellor of the Exchequer, in pursuance of their powers under the said section 5 (4), by a direction published in the Gazette on 16th June 1967, further extended the said period of three months by three months; months;

4. Now therefore the Secretary of State for Econo-mic Affairs and the Chancellor of the Exchequer, in pursuance of their powers under the said section 5 (4), hereby direct that the said period of three months be further extended by two months.

THE TRUNK ROAD (CASTLE STREET, RUTHIN) (RESTRICTION OF WAITING) ORDER 1967

ORDER 1967 Notice is hereby given that the Secretary of State has made an Order under section 26 of the Road Traffic Act 1960, the effect of which is to prohibit between the hours of 8 a.m. and 6 p.m. in that length of the Dolgelley-Bala-Ruthin-Queensferry -South of Birkenhead Trunk Road (A.494), known as Castle Street, Ruthin, in the county of Denbigh which lies between its junction with Dog Lane and a point 11 yards north of its junction with Record Street, a distance of approximately 100 yards. Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be neces-sary for a person to board or alight from the

enable a vehicle to wait for so long as may be neces-sary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.
