TOWN AND COUNTRY PLANNING ACT 1962

Blackburn

The Minister of Transport hereby gives notice that she proposes to make an Order under section 153 of the above Act to authorise the diversion of lengths of two footpaths off Shorrock Lane and Bentham Road, Blackburn, to enable development consisting of a two-form entry infants' school to be carried out by Blackburn C.B.C. under Part III of the Act.

The proposed Order will require that the new lengths of footpaths to be provided as the diversions are to be footpaths maintainable at the public expense, for which the highway authority is to be the Blackburn C.B.C.
