The QUEEN has been graciously pleased to give and grant unto Anthony Feilden Mason of Penlan, Llandegai, in the county of Caernarvon, Esquire, Her Royal Licence and Authority that he may take and henceforth use the name of Hornby in addition to and after that of Mason and may bear the Arms of Hornby quarterly with his own family Arms and that such surname and Arms may in like manner be taken, borne and used by his issue according to the Laws of Arms; the said Arms being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms: otherwise the said Royal Licence and Permission to be void and of non effect.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's said College of Arms.
