3. Now therefore, the Secretary of State for Economic Affairs, the Secretary of State for Scotland and the Minister of Health, in pursuance of their powers under the said section 5 (4), hereby direct that the said period of three months be extended by three months.

### HIGHWAYS ACT 1959

The Swansea-Manchester Trunk Road (Camnant, Kerry) Order 1967
