Notice is hereby given that on the 5th October 1967, the Council of the Borough of Hove made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit waiting at all times:

- (1) On that length of the north side of King's Esplanade commencing in line with the back of the west footpath in St. Aubyn's South and extending westwards for a distance of 540 feet.
- (2) On that length of the north side of King's Esplanade commencing in line with the back of the east footpath in St. Aubyn's South and extending eastwards to a point in line with the back of the west footpath in Medina Terrace.
- (3) On that length of the south side of King's Esplanade and the east side of Medina Terrace commencing in King's Esplanade at a point 33 feet west of the back of the west footpath in Medina Terrace and extending eastwards along the south side of King's Esplanade and then northwards along the east side of Medina Terrace to a point 30 feet north of the back of the north footpath in King's Esplanade.

This Order will contain the usual exemptions to permit vehicles to wait to pick up and set down passengers, to load and unload goods or to carry out essential services. The Order will come into operatiton on the 1st

January 1968.

### HUDDERSFIELD COUNTY BOROUGH COUNCIL

The Huddersfield (Part of Wakefield Road and Penistone Road) (Traffic Regulation) Order 1967

Notice is hereby given that on the 4th October 1967 the Huddersfield County Borough Council made an Order under sections 26 and 27 of the Road Traffic Act 1960, the effect of which is to: Prevent persons except upon the direction or with the permission of a police constable in uniform from causing or permitting any vehicle to wait on any weekday in any of the lengths of road specified in the

Schedule hereto and to prohibit the loading and unloading of vehicles on the said lengths of road between the hours of 4 p.m. and 6.30 p.m. on any weekday.

Exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary-

- for a person to board or alight from the vehicle; or
  to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, or the maintenance of the road or the services therein; or
- (3) to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties; or

(4) to enable goods to be loaded on to or unloaded from a vehicle at times otherwise than between 4 p.m. and 6.30 p.m. on any weekday.

The Order will come into operation on the 1st day of December 1967.
