

High Street, Sutton and a point opposite the north-eastern wall of No. 9 Manor Place in a direction from south-west to north-east.

2. to revoke existing street parking places in Manor Park Road.

3. to revoke existing restrictions on waiting by vehicles in Throwley Road.

4. to amend the hours during which restrictions on waiting by vehicles apply from between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive to any time of the day or night throughout the week in Carshalton Road.

5. to amend the hours during which restrictions on waiting by vehicles apply from between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive to between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in Brighton Road; Burnell Road; Cedar Road; Cheam Road; Crown Road; Greenford Road; Haddon Road; High Street, Sutton; Manor Lane; Manor Park Road; Marshall's Road; Robin Hood Lane; St. Nicholas Road; Vale Road and West Street, Sutton.

6. to impose restrictions on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:

*Beech Tree Place* between a point 60 feet south of the southern kerb-line of West Street, Sutton and a point opposite the southern wall of Nos. 1-8 Beech Tree Place.

*Benhill Avenue*

(a) the south-east side;

(i) between a point 60 feet north-east of the north-eastern kerb-line of High Street, Sutton and a point opposite the south-western boundary wall of No. 32 Benhill Avenue;

(ii) between a point 40 feet west of the western kerb-line of Lenham Road and a point 40 feet east of the eastern kerb-line of Lenham Road;

(b) the north-west side;

(i) between a point 60 feet north-east of the north-eastern kerb-line of High Street, Sutton and a point opposite the south-western wall of No. 15 Benhill Avenue;

(ii) between a point opposite the south-western wall of No. 57 Benhill Avenue and a point 40 feet east of the eastern kerb-line of Brunswick Road.

*Brighton Road* between its junction with High Street, Sutton and a point opposite the party wall of Nos. 5 and 6 Station Parade, Brighton Road.

*Brunswick Road* between its junction with Benhill Avenue and a point 40 feet north of the northern kerb-line of Benhill Avenue.

*Burnell Road* between a point opposite the party wall of Nos. 5 and 7 Burnell Road and a point 5 feet west of the western wall of No. 10 Burnell Road.

*Bushey Road* between a point 60 feet west of the western kerb-line of High Street, Sutton and a point opposite the party wall of Nos. 1 and 3 Bushey Road.

*Cedar Road* the south-east side, between a point 90 feet north-east of the south-eastern kerb-line of Brighton Road and a point opposite the south-western wall of No. 10 Cedar Road.

*Cheam Road* between the south-western kerb-line of Robin Hood Lane and a point 70 feet south-west of that kerb-line.

*Collingwood Road* the north-east side, between its junction with Robin Hood Lane and a point opposite the north-western wall of No. 4 Collingwood Road.

*Elm Grove* the south-east side, between a point 60 feet north-east of the north-eastern kerb-line of High Street, Sutton and a point opposite the north-eastern wall of No. 22 Elm Grove.

*High Street, Sutton* between a point opposite the south-easternmost wall of No. 2 High Street, Sutton and its junction with Brighton Road.

*Lenham Road*

(a) between its junction with Benhill Avenue and a point 40 feet south of the southern kerb-line of Benhill Avenue;

(b) between a point opposite the party wall of Nos. 31 and 33 Lenham Road and a point 5 feet south-east of a point opposite the south-easternmost wall of No. 34 Lenham Road;

(c) the south-west side, between its junction with Throwley Road and a point 5 feet south-east of a point opposite the south-easternmost wall of No. 10 Lenham Road;

(d) the north-east side, between its junction with Throwley Road and a point 40 feet north-west of the north-western kerb-line of Throwley Road.

*Lewis Road*

(a) between a point 40 feet north of the northern kerb-line of Burnell Road and a point 40 feet south of the southern kerb-line of Burnell Road;

(b) between its junction with Marshall's Road and a point 40 feet north of the northern kerb-line of Marshall's Road.

*Lodge Road*

(a) the north-east side, between its junction with Manor Lane and a point 40 feet north-west of the north-eastern kerb-line of Manor Lane;

(b) the south-west side, between its junction with Manor Lane and a point opposite the party wall of Nos. 22 and 24 Lodge Road.

*Manor Lane* between a point 10 feet north-west of a point opposite the party wall of Nos. 20 and 22 Manor Lane and a point 5 feet south-west of a point opposite the south-western wall of No. 26 Manor Lane.

*Manor Park Road*

the south-west side:

(i) between a point 8 feet south-east of a point opposite the north-western wall of Laleham Court, Manor Park Road and a point 24 feet south-east of that point;

(ii) between a point 10 feet north-west of a point opposite the south-eastern wall of No. 12 Manor Park Road and a point 35 feet south-east of a point opposite the party wall of Nos. 18 and 20 Manor Park Road;

(iii) between its junction with Throwley Road and a point 45 feet south-east of the southern kerb-line of Throwley Road.

*Marshall's Road* between a point 40 feet south-west of the south-western kerb-line of Lewis Road and a point opposite the party wall of Nos. 11 and 13 Marshall's Road.

*Mulgrave Road*

(a) the north-west side, between a point opposite the south-western wall of No. 22 Mulgrave Road and a point 40 feet south-west of the south-western kerb-line of Bridge Road;

(b) the south-east side, between a point 40 feet north-east of the north-eastern kerb-line of Worcester Road and a point 60 feet south-west of the south-western kerb-line of Worcester Road;

(c) between its junction with High Street, Sutton and Brighton Road and a point 40 feet south-west of the south-western kerb-line of High Street, Sutton.

*Robin Hood Lane*, the south-east to north-west arm

(a) the north-east side:

(i) between a point opposite the party wall of Nos. 66 and 68 Robin Hood Lane and its junction with Collingwood Road;

(ii) between the northern kerb-line of Cheam Road and a point opposite the party wall of Nos. 52 and 54 Robin Hood Lane;

(b) the south-west side:

(i) between the northern kerb-line of Cheam Road and a point 60 feet north-west of that kerb-line;

(ii) between a point 30 feet north-west of the north-western wall of No. 6 Robin Hood Court, Robin Hood Lane, and a point opposite the party wall of Nos. 9 and 10 Robin Hood Court, Robin Hood Lane.

*Sutton Court Road*

(a) the north-west side, between a point 60 feet north-east of the north-eastern kerb-line of High Street Sutton and its junction with Langley Park Road;

(b) the south-east side, between a point opposite the party wall of Nos. 29/31 and Nos. 33/35 Sutton Court Road and a point opposite the north-eastern wall of No. 38 Sutton Court Road.

*Throwley Road*

(a) the south side:

(i) between its junction with High Street, Sutton and a point 60 feet north-east of the north-eastern kerb-line of High Street, Sutton;

(ii) between a point 50 feet west of the south-western wall of No. 29 Throwley Road and a
