On 3rd July 1967, Corporal Burnet a member of a Specialist Team, Royal Engineers, was supervising the oiling of the Habilayn airstrip in South Arabia. The task was being carried out using a 1,000 gallon oil distributor towed by a South Arabian Army Vehicle with a Somali operator standing in the normal operating position at the rear of the distributor.

The distributor ran over an anti tank mine which exploded throwing the operator to the ground and Coroporal Burnet against the towing vehicle. The tyres of the distributor were set on fire, the tank split open spreading the oil quickly, giving rise to an

split open spreading the oil quickly, giving rise to an extremely dangerous situation.

Despite being severely shaken Corporal Burnet dragged the Somali operator to safety, and then assisted and supervised the release of the truck allowing it to be driven away shortly before the distributor was engulfed in flames.

Corporal Burnet's calm and efficient action and complete disregard for his own safety, undoubtedly saved the life of the Somali operator.
