

providing for the variation of the London—Canterbury—Dover Trunk Road (Woolwich Borough Boundary to Dartford Diversion Side Roads) Order, 1963, the effect of which is:

(a) to authorise the Minister—

(i) to vary the original diversion of Footpath No. 46 by a subway under the trunk road to alongside the railway track under railway bridge No. 804A.

(ii) to carry out improvements to Footpath No. 46.

(iii) to stop up certain lengths of the footpath south of the trunk road;

(iv) to construct new lengths of footpath giving access to this diversion all at Bexley aforesaid, and

(b) to provide for the transfer of the said new highway to the London Borough Council of Bexley as from the date on which the Minister notifies the Council that the new highway has been completed.

Copies of the Order and of the relevant plan have been deposited at the Ministry of Transport, St. Christopher House, Southwark Street, London S.E.1, where they are open to inspection free of charge at all reasonable hours. Certified copies have also been deposited at the offices of the Greater London Council, County Hall, London S.E.1, and of the Kent County Council, County Hall, Maidstone, Kent, and of the London Borough Council of Bexley, Town Hall, Erith, Kent, where they are similarly open to inspection.

Copies of the Order, the title of which is "The London—Canterbury—Dover Trunk Road (Greenwich Borough Boundary to Dartford Diversion Side Roads) No. 1 (Variation) Order 1967" can be obtained from the Ministry of Transport, St. Christopher House, Southwark Street, London S.E.1.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may within six weeks from 8th December 1967, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

LAND DRAINAGE ACT 1930

Lakenheath Internal Drainage District

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by sections 4 (3) and 14 of the Land Drainage Act 1930, as applied by the Water Resources Act 1963, has now made an Order confirming, with a modification, a Scheme submitted to him by the Great Ouse River Authority, under section 4 (1) (b) of the Land Drainage Act 1930, making provision for the alteration of the boundaries of the Lakenheath Internal Drainage District.

The Scheme affects lands in the Rural District of Mildenhall and the Parishes of Brandon, Eriswell and Lakenheath in the county of Suffolk.

The Order will become final and have effect as an Act of Parliament unless during the period ending with 11th January 1968, a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial (as prescribed in Article 6 of the Land Drainage (River Authorities) General Regulations 1965, S.I. 1965/443) praying that the Order shall be subject to special parliamentary procedure.

Denmark
