TOWN AND COUNTRY PLANNING ACT 1962

Attenborough, Notts

The Minister of Transport hereby gives notice that she has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (County of Nottingham) (No. 9) Order 1967" authorising the stopping up of a length of footpath at Attenborough, Notts, and requiring the provision of a new footpath and road.
