Lengths and sides of the Neath—Abergavenny Trunk Road (A.465) (hereinafter referred to as "the trunk road"), at Glyn-Neath, in the Rural District of Neath in the County of Glamorgan.

1. That length of the trunk road, known in part as Park Avenue and in part as High Street, which extends from a point 103 yards west of its junction with Gellidawel Road to a point 13 yards east of that junction, a distance of 116 yards.

2. The south side of that length of the trunk road, known as High Street, which extends from a point 13 yards east of its junction with Gellidawel Road to a point 50 yards east of that junction, a distance of 37 yards.

Lengths and sides of the Fishguard-Aberystwyth-Dolgelley-Caernarvon-Bangor (Menai Suspension Bridge) Trunk Road (A.487), hereinafter referred to as "the trunk road", at Dolgellau in the Urban District of Dolgellau in the County of Merioneth.

1. That length of the trunk road, known as Arran Road, which extends from its junction with Smithfield Square in an easterly direction for a distance of 200 yards.

2. That length of the trunk road, known as Upper Smithfield Street, which extends from its junction with Smithfield Square to its junction with Eldon Square, a distance of approximately 45 yards.

3. The south side of that length of the trunk road, known as Eldon Square, which extends from its junction with Upper Smithfield Street to its junction with Cader Road, a distance of approximately 27 yards.
