

6. Between a point 85 yards east of its junction with the road to Newball, east of Langworth, and a point 950 yards west of its junction with the northern arm of the B.1202 road, Wragby, a distance of approximately 3.75 miles.

7. Between its junction with Walk Lane, Langton-by-Wragby and its junction with that road to Low Baumber whose junction with the trunk road lies 300 yards west of the "Red Lion" Public House, Baumber, a distance of approximately 4.75 miles.
