

**PRIVY COUNCIL OFFICE**

At the Court at Buckingham Palace the 22nd day of March 1968

PRESENT,

The QUEEN's Most Excellent Majesty in Council

Whereas a Representation duly made to Her Majesty in Council by the Minister of Housing and Local Government that, for the protection of the Public Health, burials should be discontinued as hereinafter directed in that part of St. Andrew's Churchyard, Stainland, in the County of York, shown hatched on the plan annexed hereto, has in pursuance of an Order in Council made the 20th day of December 1967, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853 (1853 c. 134) and of all other powers Her

enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith and entirely in that part of St. Andrew's Churchyard, Stainland, in the County of York, shown hatched on the plan annexed hereto.

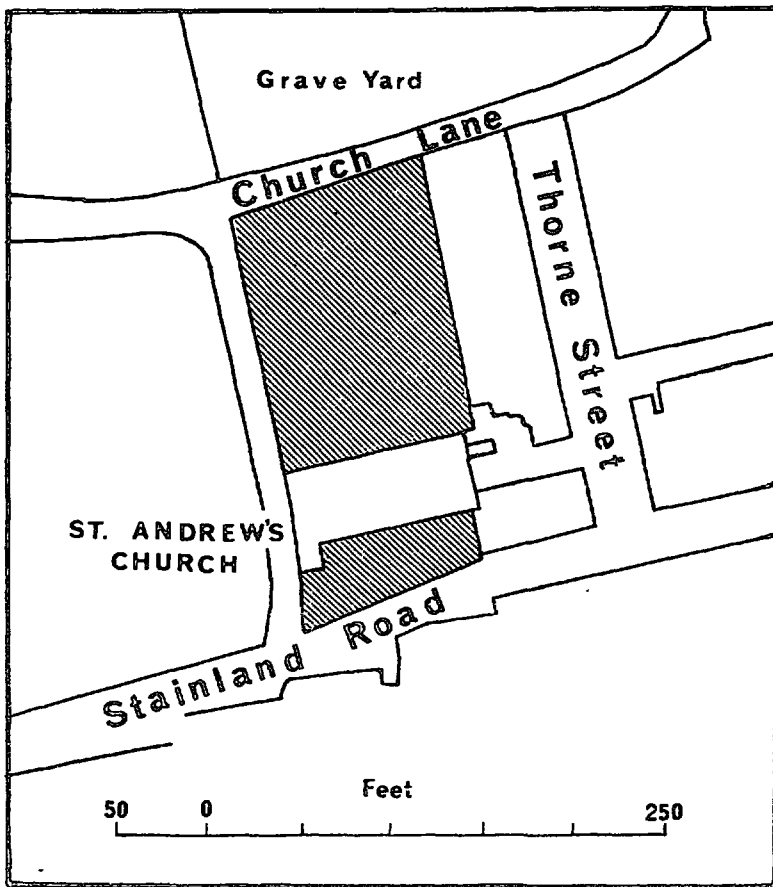
Provided that—

In any earthen grave now existing in the said part of the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds, (St. Andrew's Churchyard, Stainland, Yorkshire) Order 1968.

A BODY OF STATUTES AMENDING IN DIVERS PARTICULARS THE STATUTES OF THE COLLEGE NOW IN FORCE AND REPEALING CERTAIN PARTS THEREOF AND CONSOLIDATING THE SAME WITH THE AMENDMENTS THEREOF IN ONE BODY OF STATUTES.

Whereas the Saint Mary College of Winchester, near Winchester, otherwise called Winchester College, is a School to which the Public Schools Act, 1868, and the Acts amending the same, apply:

And whereas under the powers of the said Acts divers Statutes for the College have been from time to time made and approved in the manner provided by the said Acts, and divers of the said Statutes have from time to time been amended, repealed, or replaced, by later Statutes similarly made and approved, with the result that the Statutes of the College now in force, by virtue of the said Acts or otherwise, consist of (1) the Body of Statutes
