Its effect will be to extinguish:

- (1) Part of Footpath ECN.38 running south-easterly along the perimeter of the Airfield from its junction at Halfway Bridge on Trunk Road A.40 (main Gloucester to Cheltenham road) for a distance of 410 yards;
- (2) Part of Footpath ECN.40 running in a south-south-westerly direction commencing at a point 138 yards distant from the footpath's junction with Bamfurlong Lane south of Bank View Farm, and continuing for a distance of 220 yards;
