

(a) The north side of *Main Street* and *East End Square* from its junction with *Holyland Road* (*Harcourt Terrace*) westwards for a distance of 40 yards.

(b) The south side of *Main Street* from its junction with *Goose's Lane* westwards for a distance of 40 yards.

(c) Both sides of *Holyland Road* (*Harcourt Terrace*) from its junction with *East End Square* to the southern end of the *Railway Bridge*.

(d) The north side of *Station Road* from its junction with *East End Square* eastwards for a distance of 127 yards.

(e) The south side of *Station Road* from its junction with *East End Square* eastwards for a distance of 114 yards.

(f) Both sides of *Well Hill* from its junction with *East End Square* to a point 50 yards south of its junction with *Lower Lamphey Road*.

(g) The south side of *East End Square* from its junction with *Goose's Lane* south-eastwards for a distance of 5 yards and from a point 15 yards south-east of the same junction south-eastwards to its junction with *Well Hill*.

(h) The east side of *East End Square* from its junction with *Well Hill* to its junction with *Station Road*.

Between the hours of 8 a.m. and 6 p.m. in the undermentioned roads on the sides and for the distances indicated, vehicles shall be permitted to wait for a period of 1 hour in any period of 2 hours:

(a) The north side of *Main Street* between a point 72 yards east of its junction with *Dark Lane* and a point 175 yards east of that junction.

(b) The south side of *East End Square* from a point 5 yards south-east of *Goose's Lane* south-eastwards for a distance of 10 yards.

The Order will revoke the *Pembrokeshire County Council* (*Traffic Regulation*) (No. 1) Order, 1954.

There will be exceptions for persons boarding or alighting from vehicles, for the loading and unloading of goods, for vehicles which are being used in connection with building operations and similar works and funerals.

#### PEMBROKESHIRE COUNTY COUNCIL

*The County of Pembroke (Various Roads, Broad Haven)*  
*(Seasonal Prohibition of Waiting) Order, 1968.*
