Notice is hereby given that on the 17th April 1968, the Banbury Borough Council made Orders under sections 28 and 31 of the Road Traffic Regulation Act, 1967, the effect of which is to vary existing Orders relating to parking places (metered and un-metered) in the borough so as to provide for:

- (1) Disabled drivers to be allowed to park free of
- charge at car parks and metered parking bays during the permitted hours.) The issue of weekly tickets for certain Borough Car Parks (otherwise than metered car parks) at a cost of 5s. each. (2)
- (3) An excess charge of 10s. for vehicles remaining

 (5) The charges for the Calthorpe Street (southeast side), Factory Street and Bluebird car parks being amended to provide alternatives of sixpence for a maximum of two hours and one shilling for a maximum of four hours.
 (6) The installation of three metered parking have
- (6) The installation of three metered parking bays on land between the carriageway and the foot-path in West Bar near its junction with Horse Fair.

For the purposes of items (1) to (5) above the Orders will come into operation on 1st May 1968; for the purposes of item (6) above, the Orders will come into operation on 1st August 1968.
