*The County of Cambridgeshire and Isle of Ely (York Row and Union Place, Wisbech) (Prohibition of Waiting) (Revocation) Order 1968.*

Notice is hereby given that on the 19th April 1968 the Cambridgeshire and Isle of Ely County Council made an Order under section 2 of the Road Traffic Regulation Act 1967, the effect of which is to revoke "The County of Cambridgeshire and Isle of Ely (York Row and Union Place, Wisbech) (Prohibition of Waiting) Order 1965". The Revocation of this Order is necessary as a result of the proposals contained in "The County of Cambridgeshire and Isle of Ely (Various Streets, South of the River Nene, Wisbech) (Prohibition and Restriction of Waiting) Order 1968" which, inter alia, will:

(a) Amend the existing waiting restrictions on the north side of York Row, Wisbech from its junction with High Street to its junction with Castle Square by substituting for the daily prohibition on waiting at any time a daily prohibition on waiting between the hours of 8.30 a.m. and 6 p.m.

(b) Re-enact the existing daily prohibition on waiting at any time on the north side of Union Place, Wisbech from its junction with Castle Square to its junction with Market Street.

The Order will come into operation on the 1st May 1968.
