- No person shall cause any vehicle to proceed in any of the lengths of road specified in Schedule 2 to this notice;
- 3. No person shall cause any vehicle to proceed in that length of the Bootle-North of Aintree Trunk Road (A.567) from the north-western carriageway to the south-eastern carriageway. through the gap situated at a point 194 yards north-east of the junction of the trunk road with Park Lane West or through the gap situated at a point 660 yards north-east of that junction; and
- 4. No person shall cause any vehicle to proceed through the gap in the verge situated at a point 143 yards north-east of the junction of the Bootle-North of Aintree Trunk Road (A.567) with Park Lane West from the north-western service road to the north-western carriageway.
