(2) Where, by virtue of the provisions of paragraph (1) of this Article, the aggregate rate of additional unemployability or treatment allowances and allowances, if any, under the Family Allowances Act 1965, 1965 c. 53, or under any legislation in Northern Ireland or the Isle of Man corresponding to that Act, payable in respect of the children of a member of the naval forces who qualify therefor at 7th October 1968 is, upon the coming into operation of the said paragraph, less than it was according to the rates in force on the said 7th October, then for the period for which the said aggregate rate in respect of those children or any remaining number of them continues to be less than it would have been had the said rates remained in force, the rate of additional unemployability or treatment allowances payable in respect of those children may be varied to the extent required to exclude the reduction in the said aggregate rate. said aggregate rate.

Amendment of Schedule 7 to the 1964 Order.

-In Schedule 7 to the 1964 Order (rates of pensions, other than widows' pensions, and allowances payable in respect of death) there shall be made the amendments set out at Part II of the Appendix hereto.

Amendment of Article 19 of the 1964 Order, and consequential amendment.

3.—In the 1964 Order, in Article 19 (allowance for lowered standard of occupation) there shall be made the amendment set out in paragraph 1 of Part III of the Appendix hereto, and in Article 33 (temporary allowances to widows and unmarried dependants who lived as wives of severely disabled pensioners) there shall be made the amendments set out in paragraph 2 of the said Part.

Article added to the 1964 Order, and consequential amendment.

4.—In the 1964 Order, after Article 59 there shall be added the Article set out in paragraph 3 of Part III of the Appendix hereto, and in Article 55 (interpretation of Part VI) there shall be made the amendment set out in paragraph 4 of the said Part.

Amendment of Article 60 of the 1964 Order.

5.—In Article 60 of the 1964 Order (payment of public claims out of pensions) there shall be made the amendment set out in paragraph 5 of the said Part.

Commencement.

- 6.—(1) Subject to the following provisions of this Article, this Order shall come into operation on 5th August 1968.
- (2) Article 1 shall come into operation in relation to an officer on 8th October 1968 and in relation to a rating on 9th October 1968.
- (3) Article 2 shall come into operation in relation to an officer on 8th October 1968 and in relation to a rating on 14th October 1968.
