Common Land and Town or Village Greens: Provisional Registrations and how to object to them A. Registrations

- 1. The first period for applications for the registration under the above Act of:
 - (a) land which is common land or a town or village green;

(b) rights of common over such land, and (c) persons claiming to be owners of such land

ended on 30th June 1968.

2. The Council is the registration authority for the Administrative County of Kent. The Registers for this registration area, containing all registrations so far made are available for inspection free of charge at the County Clerk's Office, County Hall, Maidstone, between the hours of 9 a.m. and 5 p.m. on working days.

3. A table giving brief information about these registrations is at the Annex below. In addition, each local authority other than the Council has available for inspection copies of registrations affecting load in its operation.

4. The second registration period began on 1st July 1968 and will end on 2nd January 1970. During this second period, applications must normally be accompanied by a fee of £5.

B. Objections

B. Objections
1. The period for objecting to registrations made before 1st July 1968 begins on 1st October 1968 and ends on 30th September 1970. Every objection must be made in writing on the special form of objection (C.R. Form No. 26) available from 15th August onwards free and post free from the undersigned to whom it must be returned after 1st October 1968 and to arrive not later than 30th September 1970. After the latter date there will be no further opportunity for objecting to registrations made before opportunity for objecting to registrations made before 1st July 1968; those not effectively objected to will become final and definitive.

2. Every objection which is not rejected is noted on the register and particulars are sent to the person on whose application the registration was made, and to certain other persons directly interested. In addition, copies of entries of objections are sent

to local authorities.

3. The noting of an objection on the register does not mean that it is officially admitted to be correct, and it has no immediate effect on the registration. The effect is that, unless the registration is cancelled, or the objector withdraws his objection, the matter will be referred to a Commons Commissioner for decision.

4. Objections to registrations made after 30th June 1968 may not be made yet; information about this will be published shortly before 1st May 1970, the earliest date for lodging objections. Registrations are independent of each other so that, for example, a registration of land as common land made before July 1968 and not objected to before 1st October 1970 will become final and definitive on the latter date, but if registrations of rights over that land, or claims to ownership thereof, are made after 30th June 1968 objections to such registrations can be made in the second objection period.
